Restructuring of the Aakamp Group

Transfer of customer and supplier relationships from Aakamp GmbH to Ourvita Germany GmbH (formerly operating under the name La Nutré Pharma GmbH)

Dear business partners,

As long-standing and valued business partners of Aakamp GmbH and/or La Nutré Pharma GmbH, we would like to inform you about the restructuring of the Aakamp Group:

Aakamp GmbH has been merged with Ourvita Germany GmbH (formerly operating under the name La Nutré Pharma GmbH) in accordance with the provisions of the German Transformation Act. The merger, in accordance with the merger agreement dated June 25, 2025, became legally effective upon entry in the German commercial register on July 31st, 2025. The change of the company name of La Nutré Pharma GmbH to the new name Ourvita Germany GmbH took place at the same time as the entry of the merger in the commercial register.

The legal consequence of such a merger is a so-called universal succession, i.e., all rights and obligations as well as all assets and liabilities of Aakamp GmbH are automatically transferred to Ourvita Germany GmbH.

This also applies to all existing contractual relationships with you. All contractual relationships between you and Aakamp GmbH and La Nutré Pharma GmbH have been transferred to Ourvita Germany GmbH (formerly La Nutré Pharma GmbH).

We kindly ask you to update your master data to reflect Ourvita Germany GmbH with immediate effect. Aakamp GmbH is hereby deleted.
